3. Discussion and Recommendation re:

A. ID#14-0812 Removal of the 2 Hour Parking zone in the 200 block of Frame Ave.

Recommendation: Engineering staff has reviewed this item. The referral indicated to remove the entire No

Parking zone located in the 200 block of Frame Avenue. Staff confirmed with Ald. Johnson that the intent is to remove the existing 2 hour parking restrictions located on the north and south sides of Frame Avenue from S. Grand Avenue to Garfield Avenue. Back in September 2014, Staff sent a letter to residents on Frame Avenue on to inform them that the City is considering removal of the parking restrictions. Two residents responded in favor of the removal of the parking restrictions. Staff recommends

removal of the parking restrictions.

Recommended Motion: Move to rescind the existing 2 hour parking restrictions on the north and south sides of Frame Avenue from S. Grand Avenue to Garfield Avenue.

B. ID#15-2738 Modify the parking restrictions for Municipal Lot #6 to allow for overnight

parking with no changes to daytime parking or permit parking.

**Recommendation:** Staff has received and reviewed this request. We have talked with a resident of Brook

Street Condo's, discussed the issue with parking agents and reviewed the resolutions related to the parking restrictions in this lot. From staff perspective, we are in favor of all City lots to be more uniform in parking restrictions. However, Lot 6 has many distinct parking restrictions that are not uniform with other City lots and that may be outdated or not needed anymore. At this time, staff will defer to the petitioners and the committee to review the impacts of making changes to parking to allow for Brook Street Condo residents to use the lot for parking overnight, specifically on weekends. Staff will remind the committee that parking is available at the Transit Center. Staff has no

recommended motion at this time.
