Agenda Item Title: Minor Site Plan and Architectural Review – 1111 Delafield St., Remedy Medical Properties, Inc. – A request to replace deteriorated stucco siding elements on a single story addition with an EIFS cladding system, expanding on the proposal approved on April 23, 2025.	

Issue Before the Council: Proposal to replace existing stucco siding on a one story addition with EIFS.
Options & Alternatives: The Plan Commission could approve the application with or without conditions, or deny it. If the application is denied the proposal will not be able to go forward.
<p>Additional Details: In April the Plan Commission reviewed and approved a proposal from Remedy Medical Properties to replace stucco architectural accents on the building exterior with similar EIFS accents. A one story addition with white stucco cladding was not initially included in the project. After further discussion with their contractor, the applicants have decided they do want to replace the stucco on that section.</p> <p>The existing white stucco siding covers almost the entirety of the addition, with a masonry base on the south side. On the north and west sides the stucco extends to the ground. The proposal is to replace all of the stucco siding with white EIFS on a like for like basis.</p> <p>Most of the siding is separated from the nearby driveways by curb and either lawn or sidewalk, but a small section on the west side is directly adjacent to the driveway. To protect the EIFS from cars the applicants are proposing to add a metal barrier in front of that section of the building. Staff feels that that section will be visually unattractive and would like the applicant to consider other options such as adding bollards or moving the parking spaces, and associated curb stops, back a few feet.</p>
