RE: Washington, Greenwood, Wilson, & Harrison Bid Approval

The bids for the Washington, Greenwood, Wilson, & Harrison Utility & Street Improvements project were opened by the City Public Works Department at 11 am on Friday February 2, 2024. There were six (6) bidders which are shown in the table below. Action by the Board of Public Works will take place on February 8, 2024, and action by the Common Council is scheduled to occur at their February 22, 2024 meeting.

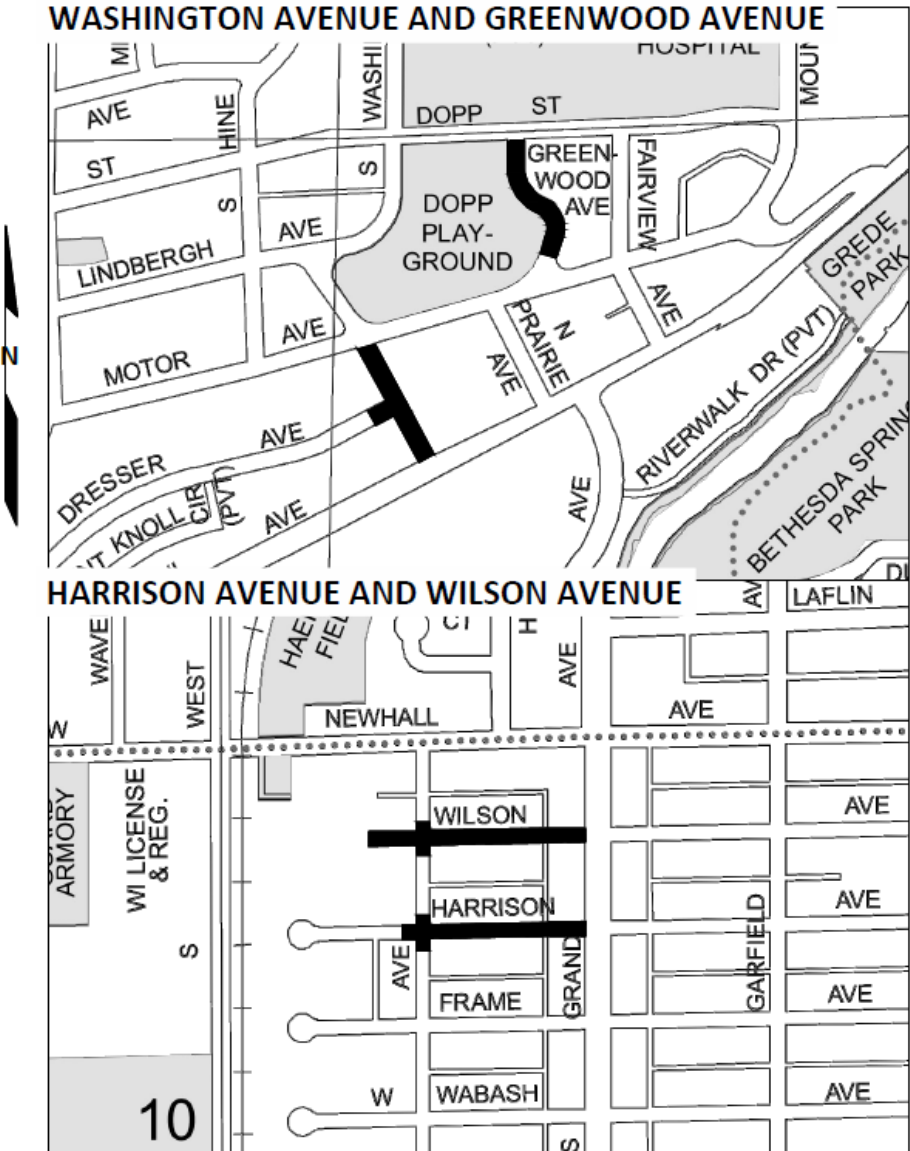

The project involves approximately 2,000 feet of 8-inch PVC water main, which is replacing 6-inch cast iron from 1924 and 1928. This project was approved as part of the 2024 budget and the engineering estimate for the Water Utility Portion of the project, was \$550,000.00. Please note that this project is being done with the City Public Works Department and the intent of this approval is to have the Water Utility approve the Water Utility's portion of the contract amount.

The funds that have been budgeted in account 3431 for this project.

Recommended Motion: Move to approve the water main replacement unit price contract and 1% city administration fee totaling \$468,281.69 for the Waukesha Water Utility's portion of the City of the Waukesha Public Works contract with Advance Construction for the Washington, Greenwood, Wilson, & Harrison Utility & Street Improvements project.
