#### Subject:

Claim for tire damage, submitted by Talia Monsivais.

#### Details:

Claimant damaged a tire on her car when she drove through an area where street re-paving was taking place. Please take a look at the photos submitted by the claimant with the claim. The photos show that a layer of the pavement had been removed for repair to a manhole. The manhole had been surrounded by a ramp of asphalt, as is standard practice, and no barricades were placed because it is safe for ordinary vehicles to drive through.

The materials submitted by claimant show that her vehicle is designed to use 235/65R17 tires. However, she had replaced the stock wheels and tires with 265/35R22 tires and 22-inch wheels. 35-series tires are extremely thin, as you can see by the claimant's photos, and are much more susceptible to damage than the stock tires. In this case, the stock tires would not have been damaged driving through the construction area. By putting 35-series tires on her vehicle, the claimant assumed the risk of damage and the duty to keep watch and not drive through areas where these special tires might be damaged.
