Those entitled to lien rights, in addition to builder, are those who contract directly with the owner or those who give the owner notice within (sixty) 60 days after they first furnish labor or materials for the construction. Accordingly, owner probably will receive notices from those who furnish labor or materials for the construction, and should give a copy of each notice received to the mortgage lender, if any.
