RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolution items were approved at the January 16, 2017 Buildings & Grounds meeting by a vote of 3 aye, 1 nay and brought forward to the February 7, 2017 Common Council Meeting for discussion under the Buildings & Grounds report.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

ID#16-1656 Rescind the previously approved (ID #16-1275) of "No Parking at any time on both sides of Walden Circle from the south lot line of 3028 to the south lot line of 3035 Walden Circle".

ID#17-0012 Establish No Parking Any Time Both Sides of Street on Walden Circle from 40 feet north of the south property line of 3028 Walden Circle to 30 feet south of the north property line of 3031 Walden Circle. Two signs will be installed in the island to demarcate this zone.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in his office as part of the original City records.
