City of Waukesha Storm Water Erosion Control Permit if disturbance over 3,000 sf</p> <p>b. Wisconsin DNR NOI, and NOI for fill site, if disturbance over 1 acre</p> <p>c. City of Waukesha – Engineering Division Construction Permit for all RW work.</p> <p>2. Additional required submittals, fees, financial guaranties needed prior to issuance of building permit include:</p> <p>a. Financial guaranties</p> <p>b. Impact fees</p> <p>c. Applicable sewer connection charges per Chapter 29.11(c) will be owed to the City for this project.</p> <p>d. City Storm Water Permit. This permit will need to be obtained prior to starting work, and obtaining a building permit.</p> <p>3. The construction drawings, and financial guarantees should be reviewed and approved prior to the construction being started and building permit issued. If the location of any work needs to be changed as a result of the approved construction drawings, the drawings should be updated to reflect the needed changes.</p> <p>4. In accordance with Wisconsin Administrative Code A-E 2.02(4): Each sheet of plans, drawings, documents, specifications and reports for architectural, landscape architectural, professional engineering, design or land surveying practice should be signed, sealed, and dated by the registrant or permit holder who prepared, or directed and controlled preparation of, the written material.</p> <p>5. Submit copy of geotechnical report (if necessary). Confirm elevation of water table on site.</p> <p>6. Add note that all work within City right of way and City easements to be in accordance with current City Standard Specifications and details.</p> <p>7. Show accessible ADA route from ADA parking spot to building entrance. Will there be an accessible entrance into building?</p> <p>8. Horizontal datum should be updated to NAD 1983/2011. See Existing Condition Survey, and City design guidelines.</p> <p>9. Submit all required checklists for Development Submittals. See City’s Development Handbook.</p> <p>10. Provide project benchmarks on cover sheet.</p> <p>11. Provide Development Handbook Statement on cover sheet per the checklist.</p> <p>12. Provide sequence of construction on erosion control plan.</p> <p>13. Provide site disturbance area.</p> <p>14. If over an acre of disturbance additional EC measures will be required.</p>
