

**RESOLUTION**

**April 16, 2019**

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolution was approved at the April 1, 2019, Building and Grounds meeting and brought forward to the April 16, 2019, Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

ID#19-0398 Install white pavement markings in the form of "X" on the south side of W. Main Street at the driveway to 423 W. Main.

ID#19-0399 Install a stop sign on Canterbury Lane at Burrie Lane.

ID#19-0401 Install a driveway apron from the back lot of 407 N. Grand Ave. to Municipal Lot 8. Said installation will require an existing handicap parking stall to be relocated one stall further south.

ID#19-0432 Rescind existing parking zones that say "No Parking, 6am to 6pm, Except Saturdays, Sundays, Holidays" on the south side of Wisconsin Avenue and approve "2 Hour Parking, 9am to 6pm, Except Saturdays, Sundays and Holidays" from 110 feet east of N. West Avenue to 90 feet west of Maple Avenue. All existing zones that say "No Parking Any Time" on the south side of Wisconsin Avenue shall remain in place from N. West Avenue to N. Barstow Street.

ID#19-0433 Rescind existing parking zones that say "No Parking, 6am to 6pm, Except Saturdays, Sundays, Holidays" on the south side of Wisconsin Avenue and approve "2 Hour Parking, 9am to 6pm, Except Saturdays, Sundays and Holidays" from 80 feet east of Maple Avenue to 100 feet west of Clinton Street. All existing zones that say "No Parking Any Time" on the south side of Wisconsin Avenue shall remain in place from N. West Avenue to N. Barstow Street.

ID#19-0434 Rescind existing parking zones that say "No Parking, 6am to 6pm, Except Saturdays, Sundays, Holidays" on the south side of Wisconsin Avenue and approve "2 Hour Parking, 9am to 6pm, Except Saturdays, Sundays and Holidays" from 110 feet east of N. Grand Avenue to 150 feet west of N. Barstow Street. All existing zones that say "No Parking Any Time" on the south side of Wisconsin Avenue shall remain in place from N. West Avenue to N. Barstow Street.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in their office as part of the original City records.
