15. Referrals

Ald. Cummings & Ald. Bartels to Plan Commission to discuss and recommend asking the Plan Commission to agendaize asking Waukesha County to conduct a Traffic Study which would look at traffic, the intersections, the roads and bridge the development of the new Kwik Trip would impact.

Ald. Cummings to the City Attorney to consider an Appeal Process which would create a Board of Appeals within the New Garbage Ordinance for those citizens and property owners who had previously received garbage pickup.

Ald.
