3. Discussion and Recommendation re:

A. <u>ID#16-155</u> Establish 4 reserved parking spaces for Adams Estates Collectibles in

the Riverfront Plaza

Recommendation: Referral was made by Public Works on behalf of Adams Estates Collectibles. Property

owner (Adams) is requesting the City to grant him 4 parking stall along the east side of Riverfront Plaza, the back side of the Adams property. In 1996, Riverfront Plaza was updated and the parking stalls behind Adams Estates were reconstructed / improved at no cost to the property owner, as said stalls were partially on the owner's property. An agreement was made with the property owner that two stalls were to be signed as

private parking for the owner.

In 2015, the owner recorded a survey document which shows the exact location of the property line in relation to the 4 parking stalls. The owner is contending that the four stalls fall partially (greater than 50% of the stall) within his property and, therefore, the

City should grant all four stalls as private parking for him.

The City contends that the original two stalls, agreed upon in 1996, will remain private parking but the owner is not entitled to any other stalls for private parking. Staff

recommends denial of this request.

B. <u>ID#16-326</u> Approve installation of an All Way stop at the intersection of Dopp Street

& Fariview Avenue.

Recommendation: Referral was made by Public Works on behalf of Waukesha Memorial Hospital. As part

of the vacation of Dopp Street to Waukesha Memorial Hospital (WMH), it was agreed that the intersection of Dopp Street & Fairview Avenue was to be approved as an All-Way Stop to promote safer driving so drivers have to stop instead of making a unrestricted right turn into, now vacated private property. The all way stop condition will also give drivers a moment to decide on redirecting their travel. Staff recommends

approval of this All Way stop.

C. ID#16-327 Approve an All Way stop at the intersection of W. Main Street & Gaspar

Street with installation at the completion of the W. Main Street

construction project.

Recommendation: Referral was made by Public Works. As a part of the design for the W. Main Street

project, engineering staff had reviewed the intersection of W. Main Street & Gaspar Street. Our study had concluded that drivers had a hard time turning from northbound Gaspar Street to W. Main Street and often got caught in the intersection. There are sharp vision restrictions due to the parked cars W. Main Street in close proximity to the intersection. Pedestrians also have a hard time crossing W. Main Street. As many as 300 pedestrians, during a 12 hour period, cross at this intersection. Some pedestrians have to wait long periods of time to cross and some have been observed running across the intersection to avoid vehicles. In order to keep a balance with vehicular flow and pedestrian flows, public works is recommending an All-Way stop to be installed.

D. ID#16-328 Approve a No Parking zone on the west side of Baxter Street from the

southern most Schuetze Center parking lot driveway to 120 feet south.

Recommendation: Referral was made by Public Works and the Parking Agents. PD Parking Agents are

concerned about vehicles parking too close to a crosswalk on Baxter Street. This crosswalk goes from the Sheutze area near the river to White Rock school. Existing No Parking zones on the west side of Baxter Street to no adequately prevent parking too close to the crosswalk, bus stop and a nearby fire hydrant. The No Parking zone requested in this item will provide a clearer curbside area in this busy location. Staff

recommends approval of this request.

E. <u>ID#16-329</u> Modify the existing No Parking zone on the west side of N. Grandview

Blvd. in front of Lowell School to be the following:

No Parking 8:30 am to 4:00 pm, Except Buses on the west side of N. Grandview Blvd. from 50 feet north to 75 feet south of Pilgrim Circle.

Recommendation: Referral was made by Public Works, Parking Agents and the School District. Recently,

Lowell School has changed the dismissal time to be slightly later. On the west side of N. Grandview Blvd., in front of Lowell School, space is designated during a period of the day for busses to park. The old time was from 8:30 am to 3:30 pm. The newer time has dismissal near 3:50 pm and, when busses arrive to park at 3:40, the stalls are taken up with parents. In order to provide space for the busses, the time needs to be

extended to 4:00 pm. Staff recommends approval of this item.
