#### **A. ID#14-0976** App

Approval of Resolution Supporting the Wisconsin Department of Transportation Request to Transfer Federal Congestion Mitigation and Air Quality (CMAQ) Funds from the Federal Highway Administration to the Federal Transit Administration on behalf of the City of Waukesha. The Wisconsin Department of Transportation (WisDOT) has awarded the City of Waukesha CMAQ funds that will cover 80% of the cost of four replacement buses. This resolution formally recongizes the City's support of WisDOT making the funds available for the purchase of the replacement buses (R#54-14)

Transit staff recommends approval of the resolution.
