Bruce Buerger 3503 White Oak Way spoke with concerns about density, runoff, price range and green space. George McNulty, adjacent property owner, indicated similar concerns about property values. Jerome Schmutte resident of Woodland Hills has concerns about runoff and the pond rising and Hwy 18 access. Doug Koehler, Principal Planner, read additional written statements of Michele Walsh 807 Conifer Ct who had traffic and runoff concerns, George Hassler and Deborah Lapp, 3501 Hawthorn Hill Dr. with traffic and storm water concerns, Glenn Reinhardt, 3519 Hawthorne Hill Dr. with traffic concerns, Peter and Jung Hee "Jina" Alles, 3508 Hawthorne Hill Dr. with concerns on storm water drainage and David Belman, Belman Homes, against the development and the zoning. Statement made by John Donovan Development Manager from Bielinski responded with comments. Public hearing was closed.
