Acceptance of Service Agreement with Peregrine		

Issue Before the Board/Council:

Requesting approval for the Waukesha Police Department to enter into an agreement with Peregrine for the installation of information-sharing software for use by officers. The agreement allows usage of the software at no cost until the state disburses the two-year funding grant award to the city of Waukesha. See attached service agreement section (service fee) for further information. The Waukesha Police Department is one of 30 agencies in Southeast Wisconsin to participate in this grant awarded by Wisconsin State Legislators.

Options & Alternatives: The goal is to showcase case studies to legislators to secure additional funding for law enforcement agencies statewide before the active grant concludes. If additional grant funding does not occur, the Police Department will coordinate with IT to identify the best solution to move forward with the possibility of terminating use of Peregrine Technology
