RESOLUTION 2023 - \_\_\_\_\_

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolution was approved at the April 3, 2023, Building and Grounds meeting and brought forward to the April 18, 2023, Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

ID#23-6206 Establish no parking on the west side of N. Charles Street from College Avenue to Alley 67.

ID#23-6381 Install a stop sign for Maitland Drive at Hawthorn Drive.

ID#23-6382

- Establish no parking on the west side of Delafield Street 100' north and 50' south of Lemira Avenue.
- Establish no parking on the east side of Delafield Street 50' north and 50' south of Lemira Avenue.
- Establish no parking on the east side of Delafield Street from 65' south of the north drive to #1001 to 10' north of the north drive to #1001.
- Establish "2 Hour Parking 6am to 6pm except Saturday, Sunday, Holiday" on the east side of Delafield Street from 10' north of the north drive to #1001 to 25' south of the drive to #1021.
- Establish no parking on the east side of Delafield Street from 25' south of the drive to #1021 to 15' north of the northern crosswalk at the intersection of Delafield Street and Washington Avenue.
- Establish no parking on the east side and west side of Delafield Street from W. Moreland Boulevard to 425' north of W. Moreland Boulevard
- Establish no parking on west side of Delafield Street from 220' north and 55' south of W. Washington Avenue.
- Establish no parking on the west side of Delafield Street from 145' north and 50' south of Magnolia Drive.

ID#23-6383 Establish a loading zone on Monday through Friday from 7:00am to 5:00pm on the south side of Pearl Street from the east side of the driveway for #1329 to the west side of the eastern driveway for #1337.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in their office as part of the original City records.
