RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolutions were approved at the May 15, 2017 Buildings & Grounds meeting and brought forward to the June 6, 2017, Common Council Meeting for approval.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

- ID#17-0736 Rescind the previously established April 7, 2009, Parking Zone that states: "No Parking, 2 a.m. to 9 a.m. Saturdays, May 9 to October 31, Tow Away Zone" which exists on north and south sides of Parking Lot 1. Said areas will revert to standard 3 hour parking 7 a.m. to 7 p.m.
- ID#17-0739 Remove existing No Parking signs associated with old bus stop west side of Tenny Avenue across from 1251 Tenny Ave.
- ID#17-0740 Establish No Parking Any Time on west side to Tenny Avenue from 250 feet north of and to the corner to E. Sunset Drive.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in their office as part of the original City records.
