Subject:

Approval of two 30 minute parking spaces at 271 W. Main St.

NOTE: This item was discussed by the committee. The original request to have 30 minute parking spaces on W. Main Street was modified to be the following:

"Approve the 2nd, 3rd and 4th parking stalls on the north side of W. Broadway east of W. Main Street be designated as temporary 30 minute parking, 7 am to 7pm, Except Sundays and Holidays. Said Temporary stalls will be removed by the City when the W. Main Street construction project is done and parking will revert back to previous parking times."

Details:

Referral was made by Ald. Helgestad on behalf of business owners on W. Main Street near E. Broadway.

Due to the construction project, some business owners would like to have two stalls designated as 30 minute stalls to allow for more turn over. Said businesses operate on a quick turn around time. Since W. Main Street will be under construction and no parking is allowed during construction, an alternative is to temporarily designate two stalls on E. Broadway to be 30 minute. The committee discussed this item and noted that the construction on W. Main Street would render this request invalid and consider designating 3 parking stalls on E. Broadway near the intersection with W. Main Street to be temporary stalls for this purpose. As indicated above, the original request to have temporary 30 minute parking spaces on W. Main Street was amended and modified to be the following:

"Approve the 2nd, 3rd and 4th parking stalls on the north side of W. Broadway east of W. Main Street be designated as temporary 30 minute parking, 7 am to 7pm, Except Sundays and Holidays. Said Temporary stalls will be removed by the City when the W. Main Street construction project is done and parking will revert back to previous parking times."

The committee voted unanimously to approve this amended item.
