Ald. Skinner arrived at 6:03 pm.

Atty Running said a year ago the City received a letter from the bank that managed its trust accounts which stated that they no longer manage trust accounts. In the process of reviewing the cemetery ordinance it was discovered that it does not provide for one of the trust accounts; it was also discovered that the current ordinance has an organizational structure that is contradictory. A goal of the draft amendment was to clearly delineate what the duties of the cemetery commission and cemetery manager are and to determine what the lines of authority are so it is clear who is supervising what. The commission is a policy making body with the day to day operation delegated to the cemetery manager. Under the proposed ordinance, the commission is going to be a policy making body but is not going to have oversight of the day to day operations, that is delegated to the cemetery manager. So the commission creates the policies or at least proposes the policies which are then approved by the council. The cemetery manager then implements the policies and makes sure that the cemetery is being run the way that the commission and council wants it run. The cemetery manager is then responsible to the city administrator.

Manion asked Nancy Falk her thoughts on the member make up going from 6 to 5 and the change in term. Running said his original draft was sent to the commission and cemetery manager with 7 members proposed; the City Administrator and Mayor reviewed it as well and suggested a 5 member commission to keep it at a manageable size. This would be accomplished by a reduction of a council member on the commission. Running said the Council will always have the final approval on commission items, so they will have the ultimate oversight. Manion prefers that the commission have 7 members. He questioned the references to cemetery manager versus the proposed cemetery director title proposed in the pending staffing amendments.

Skinner also prefers 7 members with 2 being aldermen. He supports the balance of the draft. Skinner supports a 3 year term versus a 4 year term; Manion agreed.

Johnson asked if 7 members would be unmanageable; Running does not believe that it

would.

Helgestad prefers a 7 member commission.

A motion was made by Skinner, seconded by Manion, to approve the draft ordinance with a change to 7 members (2 council members) with 3 year terms; title change from cemtery manager to cemetery director. The motion carried by the following vote:

Aye: 4 - Manion, Skinner, Johnson and Helgestad
