3. Municipal Code §11.01(9) sets the maximum penalty for harassment at \$200, which after court costs and fees are added, results in a maximum possible forfeiture of \$313.00.
4. Forfeitures for minors aged 14 to 17 are limited by Municipal Code §11.01(9)(b).
