## RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolutions were approved at the May 16, 2016 Buildings & Grounds meeting and brought forward to the June 7, 2016 Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

- ID#16-0775      Install No Parking Any Time on east side of Delafield Street from Summit Avenue to the north lot line of 607 Delafield Street.
- ID#16-0776      No Parking Any Time on west side of Delafield Street from Summit Avenue to 200 feet north.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in his office as part of the original City records.
