**AGREEMENT  
CITY OF WAUKESHA PARKS, RECREATION AND FORESTRY (WPRF)  
AND  
BADGERLAND WATER SKI SHOW (TEAM)**

Upon agreement with WPRF and TEAM to access/use the Fox River in Frame Park from April 27, 2015 through September 26, 2015:

1. The pier and jump will be placed in the river no sooner than April 27 and removed no later than September 26, 2015. Failure to comply with dates indicated will result in a \$25.00 per day fee to be billed to the TEAM.
2. The TEAM may access/use the river as per the attached schedule. Any use of the river aside from the attached dates and times will result in an additional charge of \$100.00 per date of violation.
3. If for some reason the TEAM will not be using the river as indicated on the attached schedule, they will notify the Recreation Facilities Coordinator as well as the Paddle Boat Concessionaire.
4. The TEAM must comply with the City insurance requirements. The TEAM must provide an original "Certificate of Insurance" before April 14 2015. The TEAM insurance must name "City of Waukesha Parks, Recreation and Forestry Department" as an additional insured party;  
The Team will sign a HOLD HARMLESS agreement no later than April 14 2015.
5. It is the TEAM responsibility to check the water quality and the area above and below the water to insure that the area is safe for their activity;
6. During the Water Ski Shows only, if the TEAM provides food and beverage concessions, they must notify WPRF Recreation Facilities Coordinator in advance and are responsible for securing all necessary licenses and permits.
7. The TEAM must comply with all applicable park and city ordinances. In example: No dogs are permitted in the park.
8. The TEAM will complete a Public Special Event Application. Fees will include one \$50.00 application fee for the entire season, and will be charged for 17 shows (dates attached) in accordance to the 2015 Public Event fees and charges schedule.  
Applicable fees include dock and pier daily use for shows only. Upon completion of the Public Special Event Application an invoice will be generated and 50% of the invoice will be due by May 2 2015 and the remaining 50% will be due by July 1 2015. *A late fee of \$25.00 per day will be assessed.* The practice schedule (dates attached) will not have any charges relating to the use of the Fox River.

9. The use of the bathrooms, Schuetze Recreation Center, and Frame Park must be kept the way they were found at the start of the TEAM use. A custodial fee will be billed to the TEAM if cleaning is necessary.
10. All vehicles, trailers etc. must be legally parked. No vehicles may be parked in handicapped spaces and nothing may be placed in the park overnight without prior approval.
11. Please ask visitors to respect planting beds.
12. All Badgerland TEAM members will understand and adhere to the TEAM Precautionary Duck Control Safety Procedures (on file with WPRF).
13. The Park area used by the TEAM and its spectators needs to be left in the condition as it was found.
14. WPRF will monitor the river water level throughout the season. Shoreline erosion will be evaluated throughout the summer and discussed by the Parks, Recreation and Forestry Board in the fall, 2015.
15. WPRF reserves the right to cancel and/or amend the attached schedule (In example special event or river conditions).
