RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolutions were approved at the May 2, 2016 Buildings & Grounds meeting and brought forward to the May 17, 2016 Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

- ID#16-328 Install No Parking Any Time on west side of Baxter Street from the southern most Schuetze Center parking lot driveway to 160 feet south.
- ID#16-0729 Modify parking zone on Alley 18 off South St. to be the following: Sign 1 – “No Parking Any Time Except for Loading Zone” and Sign 2 – “1 Hour Loading Zone, MON – FRI 8AM-5PM, SATURDAY 8AM TO 12PM”
- ID#16-0730 Modify parking restrictions in Parking Lot 8 to create 8 parking spaces on west side of the lot, behind 403 and 407 N. Grand Avenue to be 3 Hour Parking, Monday through Saturday, No Permit Parking Allowed.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in his office as part of the original City records.
