- 3. Public Hearing on 2016 and Five Year Community Investment Program (CIP)

Paul Fuerrer, 727 Hamilton Avenue & Tara Glenna, 1900 Harris Highland Drive spoke during the Public Hearing in favor of restoring funds for 2016 to the Woodfield Dam Project. The public hearing was closed.

4. Discussion of the 2016 and Five Year Community Investment Program (CIP)

A motion was made by Ald. Pieper, seconded by Ald. Reiland to approve the 2016 and Five Year Community Investment Program (CIP) \$30,310,139 and the five year plan.

Amendments:

A motion was made by Ald. C. Payne, seconded by Ald. Cummings for an amendment to reinstate the Woodfield Dam Project to the 2016 CIP, with an increase to account 5567.49110 (10 Year Debt) in the Park Rec Forestry budget and an increase to account 5567.68290 (Other Capital Projects) by \$299,000, and to additionally restore the lighting carryover to the Dam Project.

Payne for an amendment to include two front end loaders with increase to account 4305.49110 (10 Year Debt) in the Public Works budget by \$231,250, increase account 4305.48330 (Sale of City Property) by \$5,000, and increase to account 4333.68140 (Heavy Equipment) by \$236,250 for the first front end loader and Increase account 4305.49110 (10 Year Debt) in the Public Works budget by \$228,750, increase account 4305.48330 (Sale of City Property) by \$7,500, and increase account 4333.68140 (Heavy Equipment) for the second front end loader.
