4. Discussion and Recommendation

A. <u>ID#15-2763</u> Consider "an appeals process" which would create a "Board of Appeals"

and process within the "New Garbage Ordinance" for those citizens and property owners who had previously received garbage pick up to appeal.

Ald. Cummings brought this referral to the Committee a few months ago; she said it was determined then that it was premature until an ordinance was passed related to this item. Cummings feels that the citizens that have had garbage collection for 30 years should have a voice as to it stopping. This would only apply to a small number of residents that have had garbage collection in the past. The criteria would be that they also would have to own the property for 15 years or have a non-conforming lot or that dumpster placement and screening is not possible on the lot. They would need to meet the first criteria along with one of the other four. This would be available to a finite amount of citizens and the appeals process would have to be complete by the end of 2015. City Administrator Lehner suggested that the committee vote on a motion to refer this item to the City Attorney's Office. Ald. Pieper had budgetary concerns with this. The affected properties do receive recycling collection.

A female that owns a property in the City spoke in favor of an appeals process. Cummings said she was told to wait with her idea when the ordinance was pending; now she is fold it is too late.

Item failed for lack of a motion.

Consider amendment of Municipal Code sec. 9.11(16), concerning sales of intoxicating liquors at gas stations, to comply with recent changes in state law allowing sales of cider; make recommendation to Common Council.

Ald. Skinner struggles with this even though it is to come into compliance with state law, however, he will support it this evening. He feels there is no shortage of locations to purchase alcohol from. Ald. Perry agrees with this statement.

C. ID#15-3207

Consider the creation of an ordinance that would limit, restrict, or deny the use of porta potties in a residential area within the City of Waukesha.

Ald. Pieper said that he made this referral with Ald. Payne, who was unable to appear this evening. Ald. Johnson suggested to put this item on hold and recommended a memo be sent to the Committee and the Attorney's Office so that the Committee has something to review. Ald. Pieper suggested the Committee address the ordinance process and inform the Council of the process. A representative from Waukesha Memorial Hospital appeared, Saul Juarez Aguilar. He said WMH runs a program with non-profit organizations in an effort to educate the public in nutrition and gardening. They have a portable toilet at this location. They are mindful to keep it from being an eyesore and have fenced it and planted flowers around it. They have some neighbors that continue to be unhappy with its appearance, although he has met with others that have changed their opinion about it. No action was taken on this item.

D. ID#15-3208

Consider adding to Ordinance 7.04:

"Residents must make all reasonable attempts to park in private driveways and parkways before parking on city streets for overnight parking".

Ald. Jankowski asked that this language be added to the parking ordinance. Ald. Johnson suggested that the PD issue overnight parking citations if permits have not been purchased. Ald. Skinner said he would not be in favor of this; it would be difficult to enforce. The police sergeant in attenance commented that this would be a difficult ordinance to enforce. Ald. Manion agreed with Skinner and the police department; the term "reasonable" is subjective; he is not in support of this change. Ald. Johnson recommended that the referring aldermen do research on their ideas prior to making a referral. No action was taken on this item. Jankowski will speak with the Attorney's Office and bring this item back to the Committee.

5. Communications

Ald. Johnson will contact the City Attorney and work with the City Administrator in regard to referrals.
