A. ID#17-1199 Please Approve Installation of Autistic Child Sign on Valley Hill Drive.

Recommendation: This request was referred by Ald. Perry to have a warning sign installed on Valley Hill to

warn drivers of the potential for an autistic child that may be present in the area. This type of signing has been installed in the past on Victoria Drive and School Drive. Although the Department of Public Works feels that signing of this nature is not very effective, it can be installed as a warning sign with the stipulation that the sign is removed when the person (or family) has moved. Signs will be removed at that time.

If approved, signs shall be placed near 206 and 917 Valley Hill Drive.

**B.** ID#17-1200 Approve modification of the No Parking Zone on south side of Arcadian

Avenue to be from the corner of N. Hartwell Avenue to 135 feet west.

Recommendation: This item was brought forward by Public Work and Transit. An existing bus stop is

located on the south side of Arcadian Avenue just West of Hartwell Ave. When buses stop, they are sticking half way into the eastbound lane of traffic because vehicles are allowed to park to close to the bus stop to give the bus proper pull over clearance. Additionally, La Casa installed a new parking lot driveway west of this bus stop and the overall parking allowances from Hartwell to the rail road tracks need to be adjusted. This item, if approved will allow buses to properly pull off to pick up riders and still allow

for some parking on this side of the street.

The Department of Public Works does not have any issues with approving this item.
