


REQUEST FOR EXTENSION OF PREMISE LICENSE FOR THE SALE OF LIQUOR AND/OR BEER

- Foo of \$25,00 per event must be paid when the application is submitted
- The agent of the establishment or a designated representative must present the Operating Plan to the Ordinance and License Committee and, if deemed appropriate, to the Buildings and Grounds Committee. It is the intent of the Ordinance and License Committee not to allow extensions of premise to public property without the express input and approval of the Buildings and Grounds Committee.
- The Ordinance and License Committee does not consider an extension of premise a Block Party. The Committee defines a
 Block Party as an event intended for residential neighborhoods only.
- The Ordinance and License Committee will examine all information and consider: past problems, police concerns, impact on the neighborhood including comments from alderperson and neighbors, music, and hours of operation, and other concerns.
