4. Licenses

A. <u>ID#16-0782</u> INVITED Bartender Applications May 9, 2016

Zachary Connor appeared with Jim Taylor, agent for Taylor's People's Park. Connor has an OWI from 2015. Connor said he has completed an AODA assessment and has learned from the experience. Taylor became aware of the OWI about a month ago; he has randomly given Connor 3 breathalyzer tests, he passed all 3. Taylor does not allow his bartenders to drink while working. Taylor said Connor has been a model employee that pays child support and health insurance out of his paychecks. Taylor is willing to monitor Connor, who has worked for him for 2 years.

A motion was made by Chairperson Johnson, seconded by Helgestad, to approve the bartender application for Zachary Connor. The motion carried by the following vote:

Heather Koerbel appeared with her agent from Billy D's, Bill Dietrick. Koerbel has an OWI from several years ago and a couple recent disorderly conduct citations. The second DC is still pending; the first one was with her OWI. She has worked for Billy D's for two years. Dietrick stands behind her application.

Vandeanaben Patel appeared before the Committee for DT Bottle Stop. They were cited for not having an operator at the establishment in 2013 and 2015; an employee also sold to a minor two times in 2015; they sold to an underage person in 2012 and 2013 as well. Mrs. Patel said that she is at the store most of the time now. She is now the agent due to her husband moving to Boston; he was the agent at the time of the previous citations. The employee with the most recent violations is no longer working for them. The Attorney's Office is working on this matter as a referral from the Police Department.

Julio Alvarez appeared before the Committee for DC's Tap. He is currently working with

He was cited in 2015 for operating without a licensed bartender on premise and sale to an underage person; both of these occurred at Lucky Rabbit.

A motion was made by Perry, seconded by Manion, to approve the license applications for Fuzzy's Southside Pub & Grill, Fuzzy's Sports Bar & Grill and Lucky Rabbit. The motion carried by the following vote:

Miranda Cotton appeared before the Committee with her husband. She is agent for JR's Tap. She was cited for sale to an underage person in 2014. No citations have been received since Nov. 2014; they have passed sting operations since that time.

Fermin De La Paz appeared before the Committee for an extension of premise application. This is an annual event. It will take place on June 4, 2016. No concerns from the Police Dept.

Summit BP appeared before the Committee. In December 2015 they were cited for not having a licensed bartender on premise and sale to an underage person. The agent,

Govind Phulara was not on premise when it happened. The agent was informed by the owner that he needs to have a licensed person on premise at all times. The employee that left the premise is no longer employed by them; there is a procedure in place now to prevent this from happening again.

A motion was made by Chairperson Johnson, seconded by Manion, to approve the license applications for Summit BP. The motion carried by the following vote:

This license application for Total Events was put on hold to allow the applicants to verify the amounts due for delinquent personal property and real estate taxes.
