RESOLUTION 2022 - _____

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolution was approved at the June 6, 2022, Building and Grounds meeting and brought forward to the June 21, 2022, Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

- ID#21-2335: Study and recommend alternatives for additional lighting of the crosswalk on East Avenue at Wright Street to improve pedestrian safety.
- Upgrade the streetlight at East Avenue & Wright Street to LED D from LED C contingent upon the approval of the ARPA funds to allocate the conversion of the WE Energy leased lights from HPS to LED at the June 7, 2022, Common Council meeting.
- ID#22-4232: Install a loading zone at 409 Delafield Street (Tuscan Hall) in front of the entrance, to load and unload customers.
- Install a loading zone at 409 Delafield Street (Tuscan Hall) starting 45' northwest of Tuscan Hall's southern parking lot driveway proceeding to Tuscan Hall's southern end of their southern driveway of their northern parking lot, which is to be covered by the business owner (Tuscan Hall).
- ID#22-4234: Approve no parking on Wright Street from East Avenue to Carroll University Parking Lot 5.
- Install no parking on the north side of Wright Street from East Avenue to Carroll University Parking Lot 5.
- ID#22-4235: Approve new Parking Zones along Arcadian Avenue from Colton Street to Greenfield Avenue as a result of Arcadian Avenue reconstruction project.
- Install no parking zones along Arcadian Avenue from Rosemary Court to Greenfield Avenue:
 - On Arcadian Avenue on the north side of the road, No Parking Anytime 40' west of Rosemary Court to 70' east of Rosemary Court.
 - On Arcadian Avenue on the north side of the road, No Parking Anytime 45' west of Aurora Avenue to 60' east of Aurora Avenue.
 - On Arcadian Avenue on the north side of the road, No Parking Anytime 45' west of Oakland Avenue to 85' east of Oakland Avenue.
 - On Arcadian Avenue on the north side of the road, No Parking Anytime 40' west of Greenfield Avenue to the east.
 - On Arcadian Avenue on the south side of the road, No Parking Anytime 75' west of Woodward Street to 40' east of Woodward Street.
 - On Arcadian Avenue on the south side of the road, No Parking Anytime 55' west of Aurora Avenue to 42' east of Aurora Avenue.
 - On Arcadian Avenue on the south side of the road, No Parking Anytime 50' west of Oakland Avenue to 80' east of Oakland Avenue.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in their office as part of the original City records.
