RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolutions were approved at the February 06, 2017 Buildings & Grounds meeting and brought forward to the February 23, 2017 Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

ID#17-0013 Install No Parking Any Time on the east side of Airport Road adjacent to the Waukesha County Mental Health Center (WCMHC) at the following locations:
- from 25 feet south to 25 feet north of center of the southern most driveway to WCMHC
- from 90 feet north to 130 feet north of the center of the southern most driveway to WCMHC
- from the southern driveway of 1601 Airport Road to 25 feet south of the northern most driveway of the WCMHC

ID#17-0153 Rescind existing No Parking, 6:00 am to 6:00 pm on the south side of Eales Avenue from White Rock to Cleveland Avenue.

ID#17-0154 Install No Parking Any Time on the north and south sides of Eales Avenue from the west lot line of 814 Eales Avenue westward to and including the dead end of Eales Avenue.

ID#17-0155 Install No Parking This Side of Street on the south side of Wood Street from S. West Avenue to Waverly Place.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in his office as part of the original City records.
