Hyde Park Avenue is slated to be reconstructed in 2028 from Summit Avenue to Madison Street. With the future project, it will reconstruct all the curb ramps and evaluate the location of the utility poles to determine if those should be relocated, so the pedestrians can be better served through the intersection. As an interim improvement, it was determined to enhance the crosswalk markings.

Hyde Park Avenue to the City's typical enhanced crosswalk detail be recommended for Council Consent. The motion carried by the following vote:
