Carpentry: There are a few areas of rot in the Shake siding. Customer must get approval from the city for any carpentry repairs! **Carpentry work can be performed upon approval at an additional Time and Material charge of \$95 per man hour plus materials and is not included in the price below.** - None noted at this time

- Apply Caulk where needed in areas previously caulked where painting
- Fill woodpecker and / or large knot holes with high quality wood putty
- Remove and reset downspouts
- Remove and reset storm windows
