To whom it may concern:

SchoolCare Learning Academy is a childcare center located off of East and sunset across the street from KinderCare. We are open 7days a week 6Am-12midnight. We provide low income families safe and affordable care for their families. This letter is regards to the complaints we have gotten from our neighbors. I would like for you to keep in mind that by state licensing guidelines children must go outside every day.

This is not the first year we have had this type of issues with our neighbors, last summer the district alderman was called and he came to our center and spoke with SchoolCare owner, which they all agreed on a cut off time of 6pm, but we have been going in at 5:30because of dinner and they do not go back out after that. We all know that after the harsh winter we just had we all want to be outside when we have all the nice weather and that it does not begin to get dark until 730-8pm. Our outside times are from 10-1130AM and 3:30-530PM.

We have gotten calls from neighbors at the center telling us that we are being too loud, that they will call the police. The phone calls have been made anywhere between 11am-530 pm. I believe that there should not be any reason for any complaints at that time kids will be kids and they will be a little loud at times. Our staff tries to keep the noise level down but it is not always easy. Staff have also said that they have had neighbors go over to their fence and told them directly to "SHUT UP", I do not agree that is something that should be told to 2yrs playing on a playground, not only is that rude, but inappropriate language.

We have gotten emails warning us that they will fight us when the new it is time for out permit review came up. They have also stated that the have live so many years and that they have never heard the KinderCare kids when they go outside. Please keep in mind that these neighbors complaining are in the back of our building and KinderCare is in the front of our building across the street behind a bank parking lot. I would be amazed if they could hear KinderCare from that far away. We are doing are very best to keep the peace with the community but at the end of the day, we are a childcare center with lots of happy kids and wonderful teachers that play games and activities with the children outside.
