

**Amendment No. 1 to the
Consulting Services Contract
City of Waukesha–Donohue & Associates, Inc.
Project Name: Storm Sewer and Flood Mitigation Engineering Services-2023-2024**

This is Amendment No. 1 to the referenced Contract. The purpose of this Amendment is to extend the Contract through the end of 2026. All terms and conditions remain in force, except as specifically amended herein. The Parties acknowledge that Consultant has fully performed all of its service obligations through September 2024 under the Contract as of the date of this amendment and has been paid in full by the City through September 14, 2024.

Now, therefore the City and Consultant agree to amend the Contract as follows:

Under **4. Time**, CHANGE December 31, 2024, to “December 31, 2026.”
