### Description

#### 6' Black Vinyl Coated Chain Link Fence

79' of 6' high, black vinyl coated chain link fence, with 1 5/8" OD top rail. Chain link fabric black vinyl coated, 9 gauge(core) wire, 2" mesh. Line posts 2 1/2" OD, SS40, spaced 10' on center, driven 4'.

- 1 - 3" OD, SS40, black vinyl coated, steel pipe, end post, set in concrete foundations.
- 1 - 3" OD, SS40, black vinyl coated, steel pipe, corner post, set in concrete foundations.
- 3 - 4" OD, SS40, black vinyl coated, steel pipe, gate posts, set in concrete foundations.
  
- 1 - 6' high x 20' wide, single slide gate. Gate frame constructed of 2 1/2" OD steel pipe, welded at all corners.
  - nylon rollers with covers and sealed bearings
  - fall protection posts

#### 6' Galvanized Chain Link Fence

374' of 6' high, galvanized chain link fence, with 1 5/8" OD top rail. Chain link fabric 9 gauge wire, 2" mesh. Line posts 2 1/2" OD, SS40, spaced 10' on center, driven 4'.

- 1 - 3" OD, SS40, galvanized, steel pipe, end posts, set in concrete foundations.
- 1 - 3" OD, SS40, galvanized, steel pipe, corner posts, set in concrete foundations.
- 2 - 4" OD, SS40, galvanized, steel pipe, gate posts, set in concrete foundations.
  
- 1 - 6' high x 26' wide double swing gate. Gate frame constructed of 2" steel pipe, welded at all corners.
