RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolutions were approved at the September 19, 2016 Buildings & Grounds meeting and brought forward to the October 04, 2016 Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

- ID#16-1404 Modify existing parking zone on the north side of Arcadian Avenue, in front of La Casa, from 65 feet to 100 feet east of Caroline, to be 30 Minute Parking, 6 AM to 4 PM, Monday to Friday, Except Saturday, Sunday and Holidays.
- ID#16-1405 Install a marked and signed crosswalk on Motor Avenue and on Mountain Avenue at the west and south legs of the intersection of Motor & Mountain Avenue.
- ID#16-1406 Modify existing parking zone on the south side of Wisconsin Avenue to be No Parking 6 AM to 6 PM, Except Saturday, Sunday, and Holidays from 80 feet east of N. Grand Avenue to 120 feet west of N. Barstow Street.
- ID#16-1407 Install No Parking Any Time on the south side of Wilmont Drive from the driveway of 111 Wilmont Drive to 150 feet west.
- ID#16-1408 Modify existing parking zone on north side of School Drive to be No Parking, 9 AM to 3 PM, Sept 1 to June 15, Except Saturday, Sunday and Holidays from 100 feet east of Center Road to S. Prairie Avenue.
- ID#16-1409 Modify existing parking zone on south side of School Drive to be No Parking, 9 AM to 3 PM, Sept 1 to June 15, Except Saturday, Sunday and Holidays from Center Road to Hemit Avenue.

- ID#16-1411 Install No Parking Any Time on east side of Center Road from Burr Oak Blvd. to 110 feet north and from School Drive to 140 feet south.
- ID#16-1412 Modify the existing parking zone on west side of Center Road to be No Parking, 9 AM to 3 PM, Except Sunday and Holidays from Burr Oak Blvd. to School Drive

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in his office as part of the original City records.
