**AN ORDINANCE ESTABLISHING AND REGULATING THE SALARIES OF ELECTIVE OFFICERS OF THE CITY OF WAUKESHA, WISCONSIN**

THE COMMON COUNCIL OF THE CITY OF WAUKESHA DO ORDAIN AS FOLLOWS:

SECTION 1. The Municipal Court Judge shall be paid the salaries opposite his/her respective office in full compensation for his/her service as such officer for the period time during his/her term beginning January 1, 2006 and each January 1 in consecutive years 2007, 2008 and ending December 31, 2009:

SECTION 2. The City will pay the monthly premium cost of the group life insurance program premiums for the elected official above.

SECTION 4. The City will pay the monthly premium cost of the group dental insurance program for the elected official above as provided to non-represented City employees.

THE COMMON COUNCIL OF THE CITY OF WAUKESHA DO ORDAIN AS  
FOLLOWS:

SECTION 1. The Municipal Court Judge's salary shall be maintained at its current level for the time period beginning May 1, 2010 and ending April 30, 2014:

SECTION 5. The City shall pay to the Wisconsin Retirement System for the elected official above the employee portion of the monthly contribution to said fund.


SECTION 6. All ordinances or parts of ordinances inconsistent with or contravening this ordinance are hereby repealed.

SECTION 7. This ordinance shall be in full force and effect from and after its passage and publication.


