4. Discussion and Recommendation re:

A. [ID#18-1031](#) Please approve modifications to the existing zone of 4 Hour Parking, 7AM to 7PM, Except Sundays and Holidays on the north side of W. Main Street to be from 285 feet west to 115 feet west of Buckley Street.

**Recommendation:** This item was brought forward by Public Works and relates to the existing 4 hour parking on the west side of W. Main Street across from the Museum. With the Water Utility project, W. Main will be repaved and the opportunity arises to introduce more parking stalls on the west side of W. Main Street. This item will provide 6 more parking stalls on the west side of W. Main Street. The Department of Public Works recommends approval of this item.

This item introduces a No Parking zone on both north and south sides of Paramount Court in order to allow for space for semi trucks to back in and pull out.
