## 5. Reports

### a. Cemetery Manager's Report

*The administration and chapel building repairs have been completed. The office workstations have been setup utilizing furniture from the City Police Department.*

*We have the addition of two Administrative Assistants, Diana Hill limited term employment for 6 months and Laurie Bullis permanent part time.*

*June was a record month for both sales and services. There were 40 burials, the previous record was 27.*

*Total revenue year to date to July 31, 2021 is \$394,220.64. This is a \$93,262.66 increase from the same time frame last year.*

*Due to a dwindling inventory of niches, we are adding thin niche units to an already existing mausoleum. This eliminates the need for a costly construction project at this time. The location of these niches will be on the Feature Mausoleum in section 11. According to a National Funeral Directors Association report, Wisconsin is projected to have a cremation rate over 80 percent by 2030. We will need to consider constructing additional buildings in the near future to meet projected demands.*
