## RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolutions were approved at the June 15, 2015 Buildings & Grounds meeting and brought forward to the July 7, 2015 Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

- ID#14-0812      Rescind existing 2 hour parking zones on the north and south sides of Frame Avenue from S. Grand Avenue to Garfield Avenue.
- ID#15-2752      Approve No Parking Any Time on the south side of Summit Avenue from Sylvan Terrace to 250 feet east of the centerline of N. Moreland Blvd.
- ID#15-2753      Approve No Parking Any Time on the north side of Summit Avenue from Sylvan Terrace to 250 feet east of the centerline of N. Moreland Blvd.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in his office as part of the original City records.
