## 5. Review &amp; Act On

[ID#17-1582](#) Consider amendment of WMC 7.07(4) concerning temporary parking regulations.

*Manion suggested adding language to (b) that would require that the alderman be notified in cases of temporary parking regulation.*

*Perry recommended that warnings be issued and not tickets, when appropriate.*

*Manion stated that mail delivery is not a temporary problem and that this change should not address that problem. Rodriguez said this ordinance is written vague enough that it could prohibit blocks of parking for an undetermined period of time. She said we don't know how long a parking restriction in front of mailboxes would take to pass, if it would at all. Rodriguez doesn't support the proposed amendment as it is drafted - she would like to see "temporary" defined, and some examples of special circumstances, as it is too broad without; she would support a more narrow scope.*

*Lt. Hendricks said the signage can limit the prohibited parking times.*

**Ald. Perry made a motion to approve the proposed ordinance amendment with all three changes outlined by Atty Running (alderman notification, posting of signs, language added that the temporary traffic regulation shall exist only as long as the emergency or other special circumstance exists); motion seconded by Chairman Johnson. The motion passed by the following vote:**
