Dan Italiano appeared before the Committee for an Extension of Premise for Friday Night Live 6 pm - 9 pm. He would like two parking spaces. He is asking for seated service of alcohol, essentially what would be an extension of his sidewalk cafe permit into the two parking stall spaces. The Committee would like an opinion from the city attorney on this issue. This item is on hold.

ID#16-491 Street Closure Ordinance

The draft ordinance has been prepared. Per Johnson, the city attorney's only concern is the 30 day minimum to apply prior to an event; he prefers a 20 day minimum (section 5). Manion suggested the 30 event limit per season by an applicant that was added to the Special Event ordinance, also be added to the Street Closing ordinance.

Manion made a motion to approve 6.17 as presented with an addition to (6) to cap the events at 30 in the B-2 District, similar to 6.18(6)(e); motion seconded by Jankowski. The motion passed by the following vote:

<u>ID#16-493</u> Special Events Ordinance

Manion made a motion to approve 6.18 Special Events as presented; motion seconded by Perry. The motion passed by the following vote:

<u>ID#16-1007</u> Discuss possible amendments to Municipal Code sec. 11.41 regarding sex-offender residency restrictions.

The Committee discussed a 1,500 foot safety zone. Chief Jack said that we do have an original domicile provision in our ordinance, however, he said that the Department of

Corrections does not have to follow our ordinance. Perry said the proposed revision to the ordinance will not fix the homeless problem; there are things the State should be doing to help rectify the that situation. Jack is in favor of increasing the child safety zone. Perry would like to have as many houses as possible in the child safety zone.

This item will be on the next agenda. No action taken.
