RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolutions were approved at the August 15, 2016 Buildings & Grounds meeting and brought forward to the September 06, 2016 Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

- ID#16-1123 Install a 35 mile per hour posted speed limit on Madison St. from Prairie Song Drive to the west city limits.
- ID#16-1273 Install one Caution Autistic Child sign for northbound Delafield Street near 529 Delafield and install a second Caution Autistic Child for westbound Bidwell Avenue.
- ID#16-1274 Install No Parking Here to Corner on the east side of Gaspar Street from W. Main Street to 50 feet south.
- ID#16-1275 Install No Parking Any Time on both sides of Walden Circle from the south lot line of 3028 to the south lot line of 3035 Walden Cir.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in his office as part of the original City records.
