### Proposal:

To build a duplex in the west area of the outlot with access from Kilps Ct. West (two family dwelling)

#### Questions:

- Type of building that is being proposed duplex one unit
- Review of plans, presentation of plans
- Reason to purchase property investment (purchase from county)

## Discussion / Issues:

- Enough rental units in area already lowers property value
- · Concerns about the access off Madison Street
- Property owners like the buffer zone of the outlot
- Some history was discussed explaining the property and how it exchanged hands
- Concerns that if this were approved, what prevents further development and adding additional
- Major concerns about the access coming between the two properties and the safety with children at play
- Concerns about why the property is not taken care of
  - Consistent grass cutting
  - o On time snow removal
    - Leads to pride in the property, which is a concern if a unit is built and not lived
       in
- The neighbors as a group are against the proposal, they have been residence for a long time and when they became property owners they were under the impression that the property was not going to be developed
- Suggested that the city take the property over and to turn it into a park

## Subdivision includes:

- 32 single family
- 74 two families

William asked the property owners if they had a plan or solution to the property:

- City park
  - Were concerns about who would hang out at the park and issues that could arise with a property of that size and location
- Sell parcels to each property owner who boarders the outlot
  - o Subdivide into 12 parcels
  - o 4 adjacent property owners one would be interested, and one non-adjacent would consider
