RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolutions were approved at the February 16, 2015 Buildings & Grounds meeting and brought forward to the March 3, 2015 Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

- ID#15-1951 Approve No Parking Any Time on the east side of Buena Vista Avenue from the corner of NW Barstow Avenue to 70 feet north.
- ID#15-1952 Approve two Handicap Parking stalls on north side of W. Main Street near the River Walk path near 494 W. Main Street.
- ID#15-1953 Approve converting the third parking stall located east of N. Grand Avenue on the north side of South Street to be a 30 minute parking stall.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in his office as part of the original City records.
