Whereas Municipal Code §29.12(5) provides that those charges shall be determined by the Board of Public Works and recommended to the Common Council for approval, and	
Whereas the Board of Public Works has reviewed all sewer service charges and fees, and has determined that the charges and fees for calendar year 2015 must be revised in order to provide adequately for construction, reconstruction, improvement, extension, operation, maintenance, repair, and depreciation of the City's sewerage system, and for the payment of all or part of the principal and interest of any indebtedness incurred for those purposes, including the replacement of funds advanced by or paid from the City's general fund, all as required by Municipal Code §29.12(1);	
Now, therefore, be it resolved by the City of Waukesha Board of Public Works that:	
1. The 2015 Sewer Service Charge and Fee Schedule, attached hereto as Exhibit A, is approved and adopted in its entirety.	
2. It is recommended to the City of Waukesha Common Council that the 2015 Sewer Service Charge and Fee Schedule be approved and adopted, and be made effective as of January 1, 2015 to remain in effect until further amended by the Board of Public Works and the Common Council.
