Engineering staff had met with the Bethesda School Principal, Sella Miranda and a member of the PTO and determined that more time will be needed to review proposed changes. Staff will send an exhibit of the proposed changes to Principal Miranda and

will the exhibit will be sent to PTO members for their input.

December or first meeting in January.

**C.** ID#16-1743

Please consider an electric speed monitoring sign along E. Broadway coming towards Buchner Park on the hill. Note: Prior engineering review and recommendation.

Recommendation:

This referral was made by Ald. Vance Skinner. Back in September of 2015, Ald. Skinner approached engineering staff by email to look into issues of pedestrians having difficult time crossing E. Broadway at N. Greenfield Avenue near Buchner Park. Engineering staff conducted a traffic volume and speed study and determined that westbound drivers on E. Broadway were consistently 10 to 15 MPH over the posted speed limit of 25 MPH. The westbound direction of E. Broadway is going down hill at N. Greenfield. The westbound direction is also signed 25 MPH at 3 different locations approaching the crosswalk at N. Greenfield. One suggestion to assist in lowering the westbound speeds was to have a dynamic speed feedback sign installed on the westbound direction of E. Broadway about 200 feet west of N. Greenfield Avenue. This signs would be solar powered and provide "Your Speed" information back to the drivers in an attempt to get drivers to slow down. The sign would be turned on and off at variable times to get the best results.

The cost to install this device would be approximately in a range of \$5,000 to \$6,000. City crews would install it.

At this time, no budget exists to pay for this device. Therefore, the department of public works recommends no action on this item.
