A. ID#20-0146 Please consider changing 25 mph speed limit on Northview Road from

Grandview Blvd. west, three blocks to create a consistent speed of 35 mph

on Northview Road from Meadowbrook Road to Delafield Street.

Northview Road is 35 mph for all places except this 3 block area. (There is

no longer a school at Northview Road and Grandview Blvd.).

Recommendation:

This item was brought forward by Administrator Lahner on behalf of leaders of the Montessori School concerned with parent drop off and pick up and the adjacent Hyde Park Avenue Parking Zones conflicting with these times and activities. Also concern that cars park to close to the crosswalk. The Montessori School is currently renting the old Blair Elementary school. To that end, several suggestions were made to adjust or remove the parking zones on east side of Hyde Park Avenue. Engineering staff is presenting the subject options for changing, essentially removing, the old parking zone and adjusting the existing No Parking Any Time zone to keep vehicles from parking to close to the crosswalk. The total cost for adjusting some signing will be around \$200.

**D.** ID#20-0149 Please approve UW-Milwaukee (Waukesha Campus) to remove old way finding signs on Summit Avenue and replace them with new signs.

Recommendation: This item was brought forward by UW-Milwaukee, Waukesha Campus. On Summit

Avenue both east and west of N. University Avenue, then UW-Waukesha had way finding signing pointing the way to their campus. Today, the campus is under direction of UW-Milwaukee and they are requesting to change out the way finding signs with new ones that say UW-Milwaukee. Prior to 2017, Summit Avenue at the subject locations was under jurisdiction of WisDOT. Presently these locations are under City of Waukesha jurisdiction and require the Building and Grounds Committee to approve signing of this nature in our right of way. There is not cost to the City and all signing will be done by UW-Milwaukee Waukesha Campus hired contractor at their expense. Staff

has no issues with this request.

E. <u>ID#20-0150</u> Please modify the existing parking zone that reads "2 Hour Parking 7 am

to 4 pm Except Saturdays, Sundays and Holidays" on the north side of Lawndale Avenue, in the block from Fairview Avenue to Fairmont Avenue to be from 75 feet east of centerline of Fairview Avenue to 100 feet west of

centerline of Fairmont Avenue.

Recommendation: This item was brought forward by Public Works and Transit. Staff has been working with

Transit to adjust the street parking on Lawndale Avenue to better accommodate a bus coming northbound out of the new hospital driveway and turning left to westbound on Lawndale Avenue. The narrowness of Lawndale Avenue requires the bus to encroach into the parking lane. If a car is parked there, the bus cannot complete the turn. The subject distances describe the zone changes to accommodate a turning bus. The total cost for

adjusting some signing will be around \$200.
