-9.09(7) Rodriguez, Miller, and Johnson would like to see the number increased to four licenses, D. Lemke would like to see it be raised to three.

-9.10 (b) The committee agreed to change wording to use the State formula to determine the number Reserve licenses.

-9.12(1) The committee would like to see "when it is closed" changed to "during closing hours"

-9.13 Rodriguez would like to add "exception for extenuating circumstances if in good faith they are working to reopen the premise"
