Review and act on Contract Change Order No. 3 with J.P. Cullen & Sons, Inc., for the Waukesha Police Department Addition and Renovation project.

Details: Contract Change Order No. 3 is for additional work requested by the City for the Waukesha Police Department Addition and Renovation Project awarded to JP Cullen & Sons. During the design phase of the project the 3rd party estimate was higher than the \$17,737,230 budget. At that time the architect and the City staff worked together and removed some high price items. The bids actually came in under budget. The Council directed staff to build a building that would add 30 years to the life of the building. The City staff requested many of the originally removed items to be put back into the project. Description is as follows:
