RESOLUTION 2022

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official trafficsigns and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolution was approved at the March 7, 2022, Building and Grounds meeting and brought forward to the March 15, 2022, Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

- ID#22-2566 Install Stop Sign for the southbound traffic on NW Barstow Street at the intersection with Buena Vista Avenue.
- ID#22-2657 Rescind existing Parking Zones on E. and W. St. Paul Avenue from Mountain Avenue to Albert Street and E. and W. North Street from W. St. Paul Avenue to Pewaukee Road to accommodate the 2-way conversion project:
 - W. North Street (St Paul Avenue to Madison Street)
 - On W. North Street on the south side of the road, existing parking 385' NE of St Paul Avenue to Fuller Street.
 - On W. North Street on the south side of the road, existing no parking 100' East of Fuller Street to 150' East of Fuller Street
 - On W. North Street on the south side of the road, existing parking 225' East of Fuller Street to Madison Street
 - On W. North Street on the south side of the road, existing no parking 250' East of Fuller Street to 300' East of Fuller Street
 - On W. North Street on the North Side of the road, existing parking 125' West of Fuller Street to 50' East of Fuller Street

 - On E. North Street on the north side of the road, existing 1-hour parking from 200' East of Brook Street to NW Barstow Street.
 - E. North Street (NW Barstow Street to Maria Street)
 - On E North Street on the north side of the road, existing no parking from 200' East of Barstow Street to 300' East of NW Barstow Street.

ID#22-3658 Install Parking Zones on E. and W. St. Paul Avenue from Mountain Avenue to Albert Street and E. and W. North Street from W. St. Paul Avenue to Pewaukee Road to accommodate the 2-way conversion project as follows:

W. North Street (St Paul Avenue to Madison Street)

- On W. North Street on the south side of the road, No Parking Anytime 385' NE of St Paul Avenue to Fuller Street.
- On W. North Street on the south side of the road, No Parking Anytime 100' East of Fuller Street to 150' East of Fuller Street
- On W. North Street on the south side of the road, No Parking Anytime 225' East of Fuller Street to Madison Street
- On W. North Street on the south side of the road, 2-Hour Parking 250' East of Fuller Street to 300' East of Fuller Street
- On W. North Street on the North Side of the road, No Parking Anytime 125' West of Fuller Street to 50' East of Fuller Street
- On W. North Street on the North Side of the road, 2-Hour Parking 125' East of Fuller Street to 225' East of Fuller Street.
 - E. North Street (Madison Street to Brook Street)
- On E. North Street on the south side of the road, 2-Hour Parking from 125'
 West of Brook Street to 25' West of Brook Street.
 E. North Street (Brook St NW Barstow Street)
- On E. North Street on the north side of the road, 2-Hour Parking from 300' East of Brook Street to 400' East of Brook Street
- On E. North Street on the north side of the road, No Parking Anytime from 400' East of Brook Street to NW Barstow Street

ID#22-3559 Rescind the Yield Sign at the intersection of E. North Street and Pewaukee Road.

ID#22-3660 Install Stop Sign at the intersection of E. North Street and Pewaukee Road.
