Details:

The Contract Change Order details additional work completed by J.H. Hassinger, Inc., at the request of the City:

Item #3.1 – Additional regulator for the onsite generator

A secondary regulator was necessary to be installed between the WeEnergies meter and the on-site generator to provide the proper volume and pressure of natural gas for it to function properly.

<u>Item #3.2 – Manual transfer switch for portable generator</u>

The City requested a manual transfer switch and generator connection installed on the temporary control panel to allow the connection of a portable generator if power was lost during construction to assure pumping ability would be maintained.

<u>Item #3.3 – Control panel touchscreen upgrade</u>

Item #3.4 – Additional force main work

When the contractor exposed the force main it was determined additional fittings and piping were necessary to make the final connections over and above what was shown on the plans. The plans did not reflect the actual site conditions due to undocumented work that was done during the 1996 upgrade.
